

Legislative Recap 2013

The 83rd Legislature passed more than 1,000 new laws during the seven months it was in session and most went into effect September 1, 2013.

Regular Session: Legislators met many challenges. It is undisputed that the State's oil and gas boom and its revenue boost to the economy allowed legislators to work together in a bipartisan manner during the 83rd Legislative Session.

Key Legislation passed included:

- Budget –Funding for education, roads, water, and tax relief made contingent on approval
 of key revenue bills
- Water Priority issue for leadership receives consensus support
- Roads Counties successful in obtaining state assistance for shale roads
- Taxes/Business -Even without full margin cut, business did well in session
- Higher Education- South Texas

Special Sessions: Political agendas emerge:

- First Special Session abortion legislation takes center stage
- Second special session passes refiled bills

Spotlight Issue: Public Health

Dr. Catalina Garcia: Bird's-Eye View of Latino Public Health, By: Rodolfo Mata

Dr. Catalina Esperanza Garcia has a simple proposal for how the legal profession can serve a critical role in public health for Latino communities.

One of the biggest public health challenges, Dr. Garcia indicated, is a lack of resources for particular population groups. Latinos tend to be a forgotten group in relation to public health, and issues as basic as access to clean water supplies are insufficiently addressed. However, Dr. Garcia finds encouragement in recent funding for research on health care issues in border communities. The Federal Government has new programs — some just a few years old — to provide funding to schools to assess the issues and determine what steps should be taken to improve matters. Latinos as a group will benefit from such studies because of their high population density in border regions.Read More



A native of El Paso, Texas, Dr. Garcia received a Bachelor of Science degree from the University of Texas at El Paso, and a medical doctorate from the University of Texas Southwestern Medical School. She has served on the Texas State Board of Medical Examiners and has also dedicated her time to serving on the boards of directors for several organizations, including KERA, the National Hispana Leadership Institute, and the Dallas Mexican American Historical League. Through her education and community involvement, Dr. Garcia has become quite familiar with the public health issues of the Latino population, particularly in the border communities of Texas. Dr. Garcia recently was featured in an interesting article published by the Dallas News (read article).
